With reference to the subject mentioned above, this is for your kind information that :

1. Swami Sahajanand Saraswati B.Ed. College, Bokaro has filled a W.P.(C) no. 11633/2025 before Hon'ble High Court of Delhi to challenged the withdrawal order issued by NCTE vide letter no. NCTE/2025/ERC/PAR/ORDER/ ERCAPP1185 (70684-70690) dated 15/05/2025.
2. Hon'ble High Court, New Delhi passed a common order dated 05/08/2025 and directed the NCTE as under:
" It is further directed that respondent/ NCTE will issue a necessary Public Notice and upload the list of institutes on its website thereby intimating all concerned, including State authority, affiliating authorities and counseling authorities that **operation of the impugned withdrawal order in respect of such listed institutes have been stayed by this court and they have been permitted to participate in the counseling and admit the students for the academic session 2025-2026, which shall be complied with.**"
3. In compliance with the aforesaid direction of the Hon'ble Delhi High Court, NCTE has issued a Public Notice vide letter no. NCTE/129/2025-Legal Section-ERC Dated 11.08.2025 for information to all concerned that withdrawal order of Swami Sahajanand Saraswati B.Ed. College, Bokaro has been stayed by the Hon'ble High Court of Delhi, till the next date of hearing, and the institution has been permitted to participate in the counseling process and admit students for the academic session 2025-2026.
