Statute for B.Ed/M.Ed/B.P.Ed/M.P.Ed Course (Admission & Fee Determination) conducted by recognised institutions in the State of Jharkhand-2020

1. Short title, application and commencement:

These Statute may be called the Statute for B.Ed/M.Ed/B.P.Ed/M.P.Ed Course (Admission & Fee Determination) conducted by Recognized Institutions in the State of Jharkhand.

- 1.1 The provisions of this Statute shall be applicable for admission in Government/ Government Aided/Unaided/Self-financed and Private recognized B.Ed/M.Ed/B.P.Ed/M.P.Ed institutions/ Private Universities in the State including religious and linguistic minority Colleges.
- 1.2 The previous Ordinance notified vide letter no.- 792 dated 18.04.2018 "Ordinance for B.Ed Course (Admission & Fee Determination) conducted by recognized institutions in the State of Jharkhand-2017" shall stand superseded from the date of publication of these statute in the official gazette.
- 1.3 These Statutes are being formulated keeping the terms of provisions contained in Section 37(a) and Section 37(c) of Jharkhand State University Act (adapted and as amended), 2000 and as per NCTE Regulation 2014, Appendix-4, Section 3.3 & 3.4 the Competent Authority recommends the Statutes in relation to Admission criteria and Fee determination in recognised institutions imparting B.Ed/M.Ed/B.P.Ed/M.P.Ed teaching in the State.

All the rules and regulations, hereinafter, specified should be read as a whole for the purpose of interpretation.

2. Admission and Selection Process

- 2.1 The eligibility conditions and requirements of admission shall be such as prescribed by NCTE from time to time.
- 2.2 The selection of candidates for admission to the B.Ed/M.Ed/B.P.Ed/M.P.Ed course shall be made on the basis of ranking obtained in the B.Ed/M.Ed/B.P.Ed/M.P.Ed Entrance Test conducted by Jharkhand Combined Entrance Competitive Examination Board (JCECEB), Ranchi for that academic year. The JCECEB shall prescribe the requisite examination fee for the conduct of the Entrance test.
- 2.3 The date of B.Ed/M.Ed/B.P.Ed/M.P.Ed Entrance Test shall be announced by Jharkhand Combined Entrance Competitive Examination Board (JCECEB), Ranchi keeping in view of time line prescribed in judgement passed by Hon'ble Supreme Court in the Case No. 276/2012 (MaaVaisno Devi Mahavidyalaya Vrs. State of Uttar Pradesh & Others). In view of the above mentioned time line the admission schedule for B.Ed/M.Ed/B.P.Ed/M.P.Ed courses has been provided in section 2.4 below and the result & ranking shall be released by JCECEB, Ranchi after evaluation of answer books.

2.4 Admission Schedule for B.Ed/M.Ed/B.P.Ed/M.P.Ed Course

- 2.5 The result and ranking shall be decided on the basis of marks obtained in Common Entrance Test. The ranking list shall be prepared in descending order and shall contain twice the number of sanctioned intake. In case of tie, the relative merit of a candidate shall be resolved in the following order of preference and methodology, as specified below:
- (i) NCC 'C' Certificate/NSS Certificate.
 - (ii) Candidates having their date of birth in descending order i.e., elder will be given preference over younger candidates.
- 2.6 Reservation of seats for the candidates of reserved categories shall be as per Government's rules. The reserved category candidates shall have to submit a self-attested copy of the certificates mentioning that the candidate belongs to a particular category from an officer not below the rank of S.D.O. Eighty five (85) % of total seats are reserved for the students passing from the Universities of Jharkhand and rest for fifteen (15) % shall be open seat.
- 2.7 Application forms received shall be scrutinized by JCECEB with regard to their correctness.
- 2.8 The seat allotment shall be done through centralized counseling by JCECEB. Every year the admissions shall be regulated through a centralized counseling process by the JCECEB. On basis of category wise merit list the JCECEB with due process of counseling and seat allotment will take place as per the decision arrived at through consultation with all Universities of the State in this regard, where the self-attested testimonials submitted by the candidate shall be scrutinized. The original certificates after comparing with the duplicates shall be returned to the candidates during the counseling process itself. The JCECEB shall complete the counseling process keeping in view admission schedule for B.Ed/M.Ed/B.P.Ed/M.P.Ed courses as provided in section 2.4 above.
- 2.9 College wise list of students to be admitted must be sent by the JCECEB to the concerned colleges within seven days of counseling with copies thereof to the Universities concerned.

- 2.10 If the seats reserved for any reserved category is not filled up, the same shall be exchanged as per State Government rules/Circular orders.
- 2.11 The colleges must submit the list of admitted students to the University concerned within 30 days from the date of closure of admissions.
- 2.12 If at any time it is found that a candidate has furnished any false information, his/her candidature shall be cancelled immediately and the deposited fee shall be forfeited and suitable legal action may be initiated. The admission of any candidate can also be cancelled by the Vice Chancellor of the respective Universities by specifying the ground for the cancellation of the admission.
- 2.13 The admission process shall be completed by JCECEB, Ranchi through counselling. After that if the seats remain vacant than the remaining vacant seat shall be filled accordance with judgement passed by Hon'ble Supreme Court in the Case No. 276/2012 (Maa Vaisno Devi Mahavidyalaya Vrs. State of Uttar Pradesh & Others) and Civil Appeal No.-5914/2011(College of Professional Education Vrs. State of U.P).

3. Eligibility

- 3.1 Candidates with at least 50% (45 % in case of SC/ST/OBC PWD & other reserved categories) either Bachelor's Degree and/or in Master's Degree in Science/Social in Science/Humanities/ Commerce, Bachelor's in Engineering or Technology with specialization in Science and mathematics with 55% (50 % in case of SC/ST/OBC PWD & other reserved categories) marks or any other qualification equivalent thereto, are eligible for consideration in admission to B.Ed/M.Ed/B.P.Ed/M.P.Ed course. For admission in M.Ed/M.P.Ed, the minimum qualification shall be B.Ed/ B.P.Ed.
- 3.2 The candidate shall have to choose only one subject (within a subject category) which she/he must have studied in the qualifying degree, i.e., Bachelors' Degree or Master's Degree for at least 200 marks and obtained at least 50% in this subject. The subject will henceforth be referred to as the teaching subject in the B.Ed/M.Ed/B.P.Ed/M.P.Ed course.
- 3.3 (i) There is no restriction in the passing year to apply in B.Ed/M.Ed/B.P.Ed/M.P.Ed course
- (ii) Students in the final year of Bachelor/Master programme shall also be eligible to apply for B.Ed admission; however, their candidature shall be subject to the submission of final result and meeting the marks percentage criteria mentioned in clause 3.1.

4. Syllabus and Marking: Common Entrance Test syllabus will have three section carrying 100 questions. For every correct answer 1 mark will be awarded, while 0.25 marks will be deducted for every wrong answer. The unattended question will carry no marks. The questions will be both in Hindi & English version.

- 4.1 Language Proficiency shall have 30 questions (15 questions for Hindi & 15 questions for English) indicating specific areas like comprehension, rearranging

sentences, selecting suitable words for the blanks, finding out errors in parts of the sentences, finding out equivalent meaning to the given phrases, finding out suitable words for the incomplete sentences, sequencing, grammar which includes synonyms, antonyms, idioms, prepositions tenses, articles.

- 4.2 Teaching Aptitude (40 questions) will cover specific areas like attitude towards education, children and teaching profession; interest in teaching; leadership qualities & group management; emotional & social adjustment; intrapersonal & interpersonal skills; and general awareness of contemporary issues pertaining to school education.
- 4.3 Reasoning Ability (30 questions) indicating specific areas like verbal non-verbal reasoning, missing numbers, number series, letter series, theme finding, jumbling, analogy, odd one out, arranging the statements in a sequential form, statement and conclusions, syllogism, logical problems, establishing relationship and numerical ability.

5. **Fee Structure**

The Fee structure shall be determined by a Fee Fixation Committee constituted by the State Government. The Principles to be followed for fee fixation will be decided by the same committee.
